Croatia is currently implementing its National Qualifications Framework (CROQF), developing unit based standards of occupations and qualifications. The overall goal of the project is to maximise CROQF potential by using international experience to create new unit based qualification and occupation standards as well as to test the CROQF ability for prior learning recognition with the equal value to formal learning. Innovation will be imported to Croatia from Turkey and United Kingdom. The innovation of Level 2 unit-based qualifications in the area of Social Care for Dementia will improve the quality of services, principally for the elderly and provide an extension of the development of the CROQF by constructing a National Occupational Standard (NOS) from which the new Croatian Level 2 unit-based qualification can be developed and piloted.
